## 2020 PROPOSED BYLAW CHANGES

### Proposed change: ARTICLE IV MEMBERSHIP AND DUES

D. Emeritus. Any non-exhibitor person who has made a significant contribution to the science of court administration or rendered distinguished service in related fields may be elected as an Emeritus in the Association by a majority vote of the membership via online voting. may apply for Emeritus membership through an application process. Applications for Emeritus shall be submitted to the Membership Chair and voted on by the Board of Directors as applications are received. The results will be announced at the annual meeting. The applicants and membership will be notified of the results after the vote by the Board of Directors.

An Emeritus shall be entitled to receive copies of the association newsletter. An Emeritus may not hold another class of membership in the Association and does have the right to attend the Annual Business Meeting and chapter meetings but may not vote or hold office. An Emeritus may serve on a committee.

#### **Current Bylaw:**

D. Emeritus. Any non-exhibitor person who has made a significant contribution to the science of court administration or rendered distinguished service in related fields may be elected as an Emeritus in the Association by a majority vote of the membership via online voting. The results will be announced at the annual meeting.

An Emeritus shall be entitled to receive copies of the association newsletter. An Emeritus may not hold another class of membership in the Association and does have the right to attend the Annual Business Meeting and chapter meetings but may not vote or hold office. An Emeritus may serve on a committee.

### Proposed change: ARTICLE VI DUTIES OF OFFICERS

3. Treasurer. The Treasurer shall collect, receive and have custody of all funds of the Association with the exception of the Certification Program Funds (see AR-TICLE IX; Paragraph 14). He/She shall deposit such funds in a bank designated by the Board of Directors and shall provide for the expenditures of such funds. He/She shall make a semi-annual financial report to the officers and Board members of the Association and shall make a report to the Association at the Annual Meeting. He/She shall assume such duties in connection with the work of Treasurer as shall be designated, specified or assigned by the Board of Directors.

He/She shall deliver to his successor all Association property and records in his/her possession immediately after the installation of a new Treasurer.

The Treasurer shall be required to furnish bond in such amount as shall be determined by the Board of Directors. The premium of said bond shall be a proper expenditure of Association funds. All checks shall have the signature of the Treasurer or President, and on the unavailability of the either, the Vice-President.

The Treasurer shall present a proposed line item budget for the next fiscal year to the membership at the Annual Meeting for discussion. The Board of Directors shall vote on the budget at the Post-Conference meeting. A simple majority of members presentshall be deemed sufficient to adopt said budget. The Board of Directors shall be authorized to perform a line item transfer, providing the transfer does not result in exceeding the overall budget. Any realized line item overage shall require the Treasurer to submit a revised budget for Board approval as stated above. This may require Board approval by email. There shall be a full compliance review of all books and records of the Association each year. IRS tax forms shall be completed in compliance with current Federal law, and appropriate tax documents shall be filed by the Treasurer annually with the CPA for filing of taxes with the IRS.

## 2020 PROPOSED BYLAW CHANGES

#### **Current Bylaw:**

3. Treasurer. The Treasurer shall collect, receive and have custody of all funds of the Association with the exception of the Certification Program Funds (see ARTI-CLE IX; Paragraph 14). He/She shall deposit such funds in a bank designated by the Board of Directors and shall provide for the expenditures of such funds. He/She shall make a semi-annual financial report to the officers and Board members of the Association and shall make a report to the Association at the Annual Meeting. He/She shall assume such duties in connection with the work of Treasurer as shall be designated, specified or assigned by the Board of Directors.

## MENTAL HEALTH DURING COVID. BE KIND TO YOUR MIND.

It seems like just yesterday we were saying goodbye to 2019 and ringing in the "Roaring 20s," 2020s that is. Almost as quickly as the Waterford crystal ball dropped in Times Square at the stroke of midnight did the world enter the unchartered territory of a Pandemic. The COVID-19 Crisis of 2020 has taken us all by surprise and has disrupted our way of life, both on a personal level and professional level.

It's really hard to achieve a work-life balance when our entire way of life has changed, and keeps changing. Although we may feel helpless with all that's going on in the world around us, there are a few things that we can do to help shepherd us through the insecurities and uncertainties of the COVID-19 crisis.

#### Maintain a routine

### **Utilize your Employee Assistance Program's counseling benefit**

Many city governments offer a multi-faceted Employee Assistance Program (EAP), one of the benefits of an EAP is no-cost or low cost counseling up to a certain number of sessions. Sometimes just speaking outloud to another human and sharing your feelings can make you feel less anxious and more able to cope with what's going on in your life.

#### Take time to laugh

Laughter does a soul good. At least twice a day, take a short "laugh break." Something as simple as watching



a short video of your favorite comedian, a silly puppy howling at a siren, a kitten with wet paws "shaking it out" or watching Lucy & Ethel work an assembly line of chocolate candies on a conveyor belt. Just a little laughter can release the feel-good brain chemical serotonin and help put you at ease. As the old adage says, "laughter is the best medicine."

#### **Smell something good**

Keeping nearby something vanilla or citrus scented, like an essential oil, a diffuser, a hand crème or a candle may help alleviate tension. Studies have shown that these scents work on receptors in your brain to produce happy feelings or feelings of satisfaction.

#### **Music that heals**

Many studies have shown that adding music helps calm anxiety, prevent depression, elevate mood and promote relaxation. Tune it up and turn it up.

#### **Journaling through COVID-19**

Journaling through any crisis is often helpful with sorting out your thoughts and feelings, but journaling through a Pandemic serves two purposes. Bearing witness to the pandemic and recording how it affected you may not only help you sort through your anxiety and fears, but provide also an interesting retrospective years from now.

Using these tools and intergrating them into your daily activities may very well bring you a little more peace and calm, it may also help you become more mindful. In the meantime, take care of yourself, and of each other.



#### It's Not Goodbye....It's I'll see you later!!



### **Online Dispute Resolution – Covid-19 Resistant Court**

ave you ever heard in your many telephone calls, court appearances or citizens at the window ask this question:

### "Why can't I just do this online?"

Well in the City of Farmers Branch we heard that continuously for years and years. Yes we had some capabilities such as online payment, online deferred and a jury portal, but we did not have a window into our court that a person could reach us just as though they walked into the courtroom. That is what ODR has done for Farmers Branch. After studying the issue at length we finally discovered that an Online Dispute Resolution could provide us what we really needed to move forward and give our citizens what they desperately wanted.

We worked closely with a vendor who allowed us to customize our entire system. Many of the setup calls started out descripting steps of what happened from the moment a person walks into our courthouse. We wanted to ensure that anything you could do in person could be done through our online system. We have continued to develop and add features as we learn more about what our public needs and what works best for the court. The

ability to customize this project has allowed us to write in procedures and standing orders within our code. Our community has been thrilled with the results and so am myself. One citizen comments:

"the repeated text messages were great in reminding me to take care of business before the expiration date! this was the easiest governmental process I have ever encountered. thank you!!!"

When Covid-19 began to emerge in North Texas I did not have many concerns with how we would be able to function. In fact, our city made the decision to shut the doors to the public on March 20, 2020 and we sent most employees home. What that could mean for many courts are huge backlogs in cases? We began at that

time to reach out to people with court cases and personally invite them by phone to our eCourt website to complete their process.

We have been able to finish most all of the processes

that we would normally do in person (except things like juveniles or assault family violence charges of course). We had already found that our daily volumes had decreased substantially after the launch of the eCourt website as well. When given the option, majority of citizens had begun to "appear" through our portal. Our docket weights have decreased in size and we found that more people were taking care of things quicker and not waiting for their court dates. We have modules for Traffic, Code Enforcement, Arrest Warrant and Failure to Satisfy Judgment modules that cover majority of all of our cases.

During the Covid-19 crisis the court already had the ability to work easily from home since our ODR is a web application. Every day, the clerks log into the system and begin to work the cases and forward them to the judge or prosecutor or vice versa depending on workflow. This has allowed for everyone to stay home and stay safe as our city administration has directed us to

A few interesting things that should be looked at that surprised me when we surveyed people who utilized our system. MORE than 50% of those who engaged in the eCourt system stated they would NOT have been able to get off work and no other way to handle the citation. Further, nearly 80% of people who engage

with our system do so on a mobile device, not a PC. I find this interesting and it shows that many people are on the go and rely heavy on technology to complete important tasks such as handling criminal citations.

The simple fact that we have been live with an ODR solution since 2018 and before COVID-19 coming onto the scene, it has allowed our court to maintain some amount of continuity in an uncertain world. We continue to adjudicate cases and continue to offer a virtual lobby and courtroom to our citizens. I am grateful we did not have to shut our eyes and ears with our doors simply because we were not already listening to what our community was asking us for.

ODR has given the court to the people, for the people and on the peoples schedule when so much has been taken away from them right now.

## TMCEC Attorneys Discuss Municipal Court in the Time of COVID-19

The Covid-19 Pandemic has forced courts to re-examine fundamental processes and procedures in unprecedented ways. Six months ago, who would have thought that Texas courts would be, in some cases, conducted all court business remotely? This has raised numerous questions for municipal courts throughout the state. In this column, TMCEC Deputy Counsel Robby Chapman and General Counsel Mark Goodner sat down to discuss answers to three common questions about conducting municipal court during a pandemic.

(QUESTION 1) The Office of Court Administration issued guidance on May 4 that requires submission of an "operating plan" to the Regional Presiding Judge for the Administrative Region. What or Who is a Regional Presiding Judge?

RC: Anyone that has processed a motion to recuse or disqualify has worked with the Regional Presiding Judge for the Administrative Region. This is the judge that assigns a different judge to hear a motion to recuse or disqualify or hear a case in which the original judge is recused or disqualified. Outside of that process, most court personnel likely have not encountered their Regional Presiding Judge. There are 11 regions and one presiding judge for each region. The Governor ultimately appoints the judge under authority laid out in Section 74.005 of the Government Code.


MG: Typically, this information is readily available here: https://www.txcourts.gov/organizations/policy-funding/ <u>administrative-judicial-regions/</u>. Unfortunately, on Friday, May 8, 2020 a ransomware attack on the judicial branch network operated by OCA led to the disabling of the branch network by OCA IT staff. Currently, much of the Texas Judicial Branch websites are still down. This makes it a bit more difficult to identify Regional Presiding Judges. The Administrative Judicial Regions themselves, however are listed in Section 74.042 of the Government Code (https://statutes.capitol.texas.gov/ Docs/GV/htm/GV.74.htm). There are 11 Administrative Judicial Regions and each one serves multiple counties. Keep checking the website, but if it is still down, you can find your region and then search google for the Regional Presiding Judge for that region. There are some other sites that usually pop up. Of course, we can always do what court personnel are very good at doing-checking with colleagues in the county to see if they have the information!

RC: The other question is, why send the operating plan to the Regional Presiding Judge of the Administrative Region? The duties and authority of that judge are also spelled out in the Government Code. Among other things, these include advising local courts on case flow management, ensuring implementation of guidelines set by the Supreme Court, and improving the administration of justice. (QUESTION 2) What are the requirements for my judge's continuing education hours during the pandemic?

MG: All municipal judges are still required to annually complete 16 hours of judicial education between September 1st and August 31st. On March 30, 2020, however, The Texas Court of Criminal Appeals issued an Emergency Order Regarding the Rules of Judicial Education. The order suspended portions of the rules that require live, continuous hours of judicial education that would prevent a judge from completing his or her hours during the disaster. Now, all 16 hours can be completed by electronic means until thirty days after the Governor lifts the Declaration of State of Disaster. TMCEC continues to offer new webinars frequently, and there are over 200 webinars on demand currently. Additionally, all sessions from the 2020 regional judges seminars are recorded and available on TMCEC's Online Learning Center.




RC: Certified court clerks are also still required to complete continuing education in order to maintain certification. Levels I and II must complete 12 hours. Level III must complete 20 hours. On March 17, 2020, though, our partners at the Texas Court Clerks Association released a statement authorizing all of the hours for this academic year to be completed through TMCEC webinars. The requirement is that it must be either a live or archived TMCEC webinar. And the hours must be recorded in the clerk's TMCEC profile on or before August 31, 2020. This only pertains to the current academic year, ending on that date. As Mark said, there are over 200 webinars currently available on the TMCEC Online Learning Center (OLC), with more being added each week. All sessions from this year's regional clerks seminars are also available as recordings under "FY 20 Regional Clerks" on the OLC.

### (QUESTION 3) What is the authority to conduct court proceedings remotely?

RC: Authority to conduct court remotely was quite limited prior to the pandemic. In fact, this question came up at the Austin Legislative Update. At the time, direct authority for video or telephone proceedings in a courtroom was limited by Article 45.0201 of the Code of Criminal Procedure to Capias Pro Fine Show Cause Hearings or the new Reconsideration of Fine or Cost Hearings. Of course, nobody then could have imagined that Texas courts would be going full on George Jetson soon! The current and much broader authority to conduct court remotely is found in the Emergency Orders issued by the Supreme Court and Court of Criminal Appeals.


MG: I agree, there was some limited authority for handing things through videoconferencing—Art. 15.17 Magistration hearings and Article 45.046 Commitment hearings also come to mind—but that changed on March 13, 2020 with


the issuance of Emergency Order 1 by the Supreme Court and the Court of Criminal Appeals. Emergency Order 1 permitted all courts to allow or require remote participation in hearings by everyone except jurors. Less than a week later, in Emergency Order 3, courts were prohibited from conducting non-essential proceedings in person. Both orders were later clarified and amended by the 12th Emergency Order on April 27, 2020. Under that order, the authority to allow anyone (other than a petit juror) involved in any hearing or proceeding of any kind to participate remotely by teleconferencing, videoconferencing, or other means was extended until June 1, 2020. Additionally, courts were told they must not conduct in-person proceedings contrary to OCA guidance. More recently, courts were given guidance regarding proceedings on or after June 1, 2020. In the guidance, courts are told they should use all reasonable efforts to conduct proceedings remotely. In fact, according to OCA, both essential and non-essential proceedings should occur remotely unless court participants are unable to successfully participate in a remote hearing for reasons beyond the court's control. In other words, the court should not be the reason that remote proceedings are not happening. This guidance is in effect indefinitely, until further updated.
